Some of the things the council has been working on in the community are environmental projects, street light upgrades, and finishing up the oil spill. Now that the new incinerator is at the dump, the next step will be to hire a landfill operator and get them trained to operate the burner. The first phase of the street light project has been done, and next the electrician will make one more trip up in the next month to complete the installation of six new LED streetlights. The new streetlights will improve visibility and safety in the community, as well as result in energy cost savings. Another project that will be moving forward is the new housing that IRHA will be overseeing. There are lots owned by the tribe located by the tribal building that will be used for the sites of the new homes. The project will move forward once all environmental and necessary reviews are done. Now that we are making progress on some of these projects, the council would like to plan and start implementing other projects in the community. The clinic grand opening and elections will take place in August, continue reading for more details. We must continue to work together to make our community strong and thriving. Mahsi' choo! Environmental News

Throughout 2018, the Birch Creek Tribal Environmental Department has completed various tasks and continue to build capacity for the health and environmental wellbeing of the residents of Birch Creek. Various Heavy Equipment pieces have successfully been restored and fixed to complete various projects for the oil spill clean-up and the overall landfill clean-up that was done this July 2018. Many of these projects have been completed by heavy equipment mechanics such as Shane Sparks earlier this spring and Edward Swift who carried on the projects early in June until recently and Hazmat Specialist, Lance Whitwell of Venetie. We are grateful for the teamwork of our KBC Environmental personnel who have coordinated efforts in Birch Creek to help out our contractors and making them feel at home your community. A new four wheeler was purchased early this summer for the IGAP program which will assist with trash pick-up with the containers that were given out to each residence and occasional landfill compliance runs. The new burn barrel has been set up at the landfill and once we have personnel trained to operate the unit, a landfill operator will man the barrel during burn times. The drums that are located at the centralized location of town were tested to see if we can burn the oil and it turned out to be, out of 49 drums 35% are able to burn in the used oil burner that will heat the Tribal Building. Edward Swift just completed the landfill clean-up to include fixing the fencing that has been on the schedule to get done within the past couple of years. We are so excited for the next steps in operating a safe and clean landfill!

The Health Insurance Portability and Accountability Act of 1996 (HIPAA) established a set of national standards for the protection of certain health information and requires the protection and confidential handling of protected health information, among other things. Tribal Member Services

• Employment/Education Scholarships, Adult Education

- Scholarships- The Tribe provides financial assistance to tribal members attending a higher educational institution at the certificate and higher level.
- o Adult Education- provides funding for training and GED services.
- Job, Placement & Traininig- Provides funding for work gear and other services to help tribal members with gainining and maintaining employment.

Medical Assistance

- Emergency Medical Assistance Assistance for resident tribal members who have to travel for medical purposes and do not have Medicaid or other assistance.
- Eyeglass Assistance- Provides financial assistance for contacts and eyeglasses
- Dental Assistance- Provides financial assistance for braces, crowns, and other procedures not covered by I.H.S.
- ***Please apply in advance, we need at least one day notice, we do not issue same day assistance unless absolutely necessary

School Supplies (pending council approval for 2018)

 Provides financial assistance for tribal council members attending K-12 to purchase school supplies and clothing.
